Von Dr. Robert Klein, als Masseverwalter der Panthax GmbH (vormals Higgins GmbH), erging am 11. Februar 2026 an den allgemein beideten und gerichtlich zertifizierten Sachverständigen Prof. KR DI Dr. Gerhard Hrebicek, MBA der Auftrag, ein Bewertungsgutachten zum Wert der Marke HIGGINS zu erstatten.

Als Informationen wurden mir die Saldenliste per 18.12.2025, das Beauftragungsschreiben sowie die Markenregistrauszüge (WIPO Global Brand Database, Stand 12. Februar 2026) übermittelt. Auf Basis dieser Unterlagen sowie Kostenschätzungen aus Erfahrungswerten wurde die Marke nach zwei Verfahren bewertet:

Es wurden Bewertungen nach dem **Kostenverfahren** (Wiederbeschaffungskostenmethode) sowie nach dem **DCF-Verfahren** (Relief-from-Royalty, Lizenzpreisanalogie) durchgeführt.

Dabei ist darauf hinzuweisen, dass eine Bewertung nach dem Kostenverfahren in der Regel die **Untergrenze** der **Bewertungsbandbreite** darstellt. Die enge Konvergenz beider Verfahren bestätigt die Robustheit des Ergebnisses.

Ergänzend zu den beiden Bewertungsverfahren wurde im Falle des hier vorliegenden Insolvenzverfahrens auch das Szenario einer **sofortigen Liquidation** berücksichtigt, um einen absoluten „Bodenwert“ als untere Wertgrenze der Marke abzuleiten.
